**ORDINANCE 2019-11**

**AN ORDINANCE ADOPTING THE VERNAL CITY BUDGET RE-OPENER #2 FOR FISCAL YEAR 2018-2019.**

**BE IT ORDAINED BY THE CITY COUNCIL OF VERNAL, UTAH:**

**SECTION 1. Adoption of Budget Reopener #2.** Pursuant to the laws of the State of Utah, the Vernal City Council hereby approves and adopts the Vernal City Budget Reopener #2 for Fiscal Year 2018-2019 by reference including the general fund, water fund, sewer fund, solid waste fund, Municipal Building Authority Fund, strike force fund, wage and salary schedules, and other miscellaneous funds in the City. Three copies of said Budget Reopener are on file for use and examination by the public in the office of the Vernal City Recorder at 374 East Main Street.

**SECTION 2. Repealer.** All former ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance or of the code are hereby repealed.

**SECTION 3. Severability.** The provisions of this ordinance shall be severable and if any provision thereof or the application of such provision under any circumstances is held invalid and it shall not affect the validity of any other provision of this ordinance or the application in a different circumstance.

**SECTION 4. Effective Date.** This ordinance shall become effective the last day of June, 2019.
