TYPE OF ALCOHOLIC BUSINESS LICENSE FOR WHICH APPLICATION IS MADE:

- Class "A" Beer:**
Retail sales in original container for consumption off-premise only. Fee: \$150.00 per annum.
- Class "B" Beer:**
Retail sales for on-premise consumption. (Restaurant License.) Fee: \$200.00 per annum.
- Class "C" Beer:**
Retail sales on draft or in Original containers for on-premises consumption. No minors allowed. (Tavern License)
Fee: Initial application \$1500.00 first year. Renewal \$300.00 per annum.
- Class "D" Beer:**
Retail sales by concession contract on or within publicly owned facility for on-premises consumption (not in Bottles). Fee \$25.00 per day up to seven days. Any period longer than seven days is \$200.00 per annum.
- Class "E" Beer:**
Retail sales on draft or in original container for on-premises consumption for a period of less than 30 days. No minors allowed. Fee: \$25.00 per day or any part thereof.
- Liquor Sales and / or Consumption License:**
Sales and / or consumption of liquor on premises. Fee: \$25.00 per day or any part thereof up to seven days. Any period longer than seven days is \$200.00 per annum.
- Beer Consumption License for Recreational Facilities:**
Consumption of beer not in bottles on publicly owned recreational facilities. Fee: \$25.00 per day or any part thereof.

I am over the age of 21 years. I have complied with the provisions of the Liquor Control Act of Utah and the applicable regulations of the Utah State Alcoholic Beverage Commission. I have not been convicted of a felony or of any violation of any law or ordinance, or pleaded guilty to or forfeited bail on a charge of having committed a felony or of having violated any such law or ordinance.

I have complied with the requirements and possess the qualifications specified in the Business License Code of Vernal City, Utah and the Liquor Control Act of the State of Utah.

I agree that if the license is issued, it is subject to revocation as provided in the Business License Code of Vernal City, Utah and the Liquor Control Act of the State of Utah, and hereby agree to comply with all provisions of such, and any regulations and ordinances.
